



## 2024 Garage Rental Agreement

To reserve a garage for the 2024 NEMRR season, complete and return this form by the deadline of March 1, 2024. A full-season rental is \$1,500.00 payable in two payments of \$750.00 each. The first payment is due on March 01, 2024, second payment is due on July 10, 2024. Full payment is also an option. Garages will be available on a first come, first serve basis after March 1, 2024. Payment must be made before renters may occupy a garage. Failure to meet payment deadlines will result in forfeiture of garage.

Tire and fuel drum disposal is not part of the garage fee. All renters must ensure tires and fuel drums are NOT left behind after an event or a fine will be incurred. All garage space must be clean and empty of all trash. I understand that I am responsible for all people and or animals in my garage at all times and will be held accountable for their actions if there should be any issues.

Garage parking passes *are* different from Camping passes. Garage renters may stay overnight ("camp") in the parking area assigned to your garage space. However, if you are staying overnight *anywhere* else on NHMS property you **MUST** pay for and properly display a separate Camping pass. Camping passes can be obtained through the NHMS Operations Office at the Main Gate.

Garage renters must monitor their parking spaces. Four (4) parking spaces are assigned per garage bay with the signer of this agreement automatically being one. All vehicles must fit in the assigned parking spaces that coordinate with your garage. For example, four vehicles in their assigned spots *are* considered acceptable. Guests without enough space must be directed to other parking areas. **NO EXCEPTIONS WILL BE MADE TO THIS RULE.**

**I understand by signing this rental agreement, that I am obligated to pay the full amount for the garage rental, whether I use the bay and/or attend any event(s) or not.** I understand that the minimum payment of \$750.00 is due on the dates listed above if I have not already paid in full. If at any time after this agreement is signed that I choose to relinquish my garage, I understand that I am still responsible for full payment or I have the option to find a replacement to take over my garage. I will notify the NEMRR Series Director of such changes. I also acknowledge that I have read the NEMRR rules and regulations and agree for myself and anyone in my garage to abide by the rules. I agree that my failure to do so will result in my losing garage bay rental privileges and fines.
